towards modern slavery and human trafficking. This Statement sets out PM Group's actions to understand all potential modern slavery risks to its business and to put in place steps that are aimed at ensuring there is no modern slavery or human trafficking in its own

business and its supply chains. This Statement has been published in accordance with section 54 of the UK Modern Slavery Act 2015 and applies to the financial year ending 31 December 2022

Assessment of Supply Chain
PM Group will not utilise the services of suppliers who have links to modern slavery and human trafficking. As part of this commitment PM Group undertake due diligence when considering engagement with new suppliers and regularly review our existing supply chain. Further details on due diligence processes (including the supplier prequalification and approvals process) are included in the full Statement available on PM Group's manageavailable on PM Group's management system.

Risk Assessment & Man-

agement
In 2022, a Modern Slavery
Working Group, was created
which meets quarterly to progress our goals. In order to
fully assess our risk, a mapping
exercise has commenced of our
existing direct suppliers. This
will allow us to categorise our
supply chain and identify any
risks further down the chain.
Once concluded, a full risk assessment will be conducted,
and actions identified where
necessary to reduce risk and
ensure compliance.

Measuring Effectiveness
Following the mapping exercise and risk assessment to identify any potential risks of modern slavery within our business and supply chain, we are currently developing a set of KPIs to monitor and report on the effectiveness of our policies and procedures governing modern slavery risks.

In the meantime, since the 2022 statement, no reported instances of Modern Slavery within the business or supply chain have been received.

**Training for Employees**Communication of this Statement

and the associated policies is important as they outline both employee and employer responsibilities to comply with the UK Modern Slavery Act 2015. Therefore, this Statement forms part of the standard PM Group on-boarding.

We conduct Employment Law training for our senior management, which includes a modern slavery awareness section. In addition, we have created a Toolbox talk on modern slavery, Gangmasters & Labour Abuse Authority for our site-based personnel so they can be vigilant to the signs and know where to report concerns concerns.

In 2023 we plan to pilot specific training on modern slavery. We will be able to track training completion via our eLearning System as a KPI from the 2023 statement.

## Goals for 2023

Throughout 2023 PM Group plan to undertake the following activities:

- Conclude mapping exercise and develop plan to assess risk as well as review our contractual obliga-tions (where necessary)
- Continue to improve modern slavery awareness amongst senior management and anyone managing supply chains via e-learning.
- Develop KPIs to ensure effective-ness of our policies and proce-dures governing modern slavery

Approval
PM Group Directors shall be responsible for the application of this Statement and for ensuring all activities comply with the UK Modern Slavery Act 2015. PM Group will provide adequate resources, training and investment to ensure successful application of this Statement throughout the next financial year.
